## FLAGSTAFF'S 10-YEAR HOUSING PLAN

The Draft 10-Year Housing Plan's public comment period has officially closed. The community forum garnered 327 responses. Coupling these with the comments received through the presentations and community outreach, there are more than 600 written comments. Housing and Comprehensive Planners are working to review and categorize the comments.

Staff will present the final 10-Year Housing Plan to the Housing Commission on January 27, 2022 and to Flagstaff City Council for consideration of adoption on February 15, 2022.

## NOTICE OF AVAILABLE FUNDING OF COMMUNITY DEVELOPMENT BLOCK GRANTS!

The Community Development Block Grant (CDBG) cycle for the 2022 Program Year will kick off right after the new year! On **January 13, 2022 at 11 am**, City staff will host the annual Notice of Funding Available (NoFA) public meeting. The meeting will be held virtually and a link for the meeting is posted on the [CDBG webpage](#). Staff will offer a presentation to community members and interested agencies on the basics of CDBG, its potential uses, and the City's NoFA and award process.

Immediately following the meeting, the application will be released. Technical assistance meetings with the Housing Section's CDBG Administrator, Kristine Pavlik, are strongly encouraged. ## INCENTIVE POLICY FOR AFFORDABLE HOUSING

Meetings with the Working Group are complete for the time being, and Project Managers are now reviewing the existing incentive policy for content to carry over into the revised incentive strategy document. A draft of the new strategy is in the works. New concepts for both the zoning code and fee-based incentives are being reviewed with the Advisory team over several meetings. Input from the Advisors will clarify direction and content to be discussed in a preliminary City Council work session this winter.

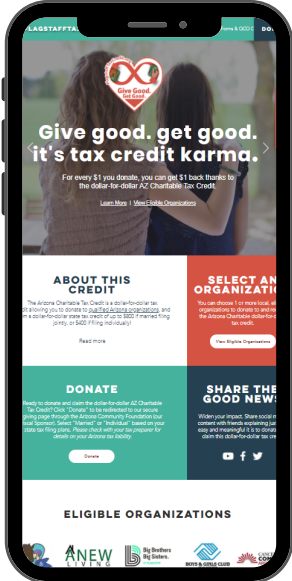

# CITY OF FLAGSTAFF HOMEBUYER ASSISTANCE PROGRAMS

The City of Flagstaff provides down payment and closing cost assistance, as well as affordable homeownership opportunities through the land trust/deed-restricted program.

- The **Community Land Trust Program** offers affordable ownership for low to moderate-income households through a shared equity homeownership model. In exchange for an affordable purchase price, homeowners agree to limit their equity so that the next qualified buyer can benefit from an affordable sales price. This agreement is secured in a ground lease between the City and the homeowner. Interested buyers must meet specific requirements to qualify for purchase. - The **Community Housing Assistance Program (CHAP)** is intended to educate and serve households that are working towards the purchase of a home within the Flagstaff city limits. Funded by the City of Flagstaff, CHAP is a down payment and closing cost assistance program that provides up to \$15,000 in matching funds to households to purchase a home but are otherwise mortgage-eligible based on credit and employment. - The **Employer Assisted Housing (EAH)** program provides up to \$10,000 per household to eligible City of Flagstaff employees to be used for down payment and/or closing cost on the purchase of a home. EAH funds will match buyer contribution on a dollar-for-dollar basis up to a benefit of \$10,000 per household. To learn more, [download the flyer \(PDF\)](#).

## FLAGSTAFF TAX CREDIT COALITION

The Flagstaff Tax Credit Coalition is a group of local qualified organizations that work to meet the basic needs of Flagstaff low-income neighbors. Donations to qualified organizations qualify for a state income tax credit. Arizona taxpayers can donate to one or more qualified members and get those dollars back in a dollar-for-dollar state tax credit on their 2021 state income taxes. Individuals can receive up to \$400 and couples filing jointly can receive up to \$800.

The AZ Charitable Tax Credit is a powerful tool to help AZ taxpayers direct their tax dollars to local proven programs, helping to meet basic needs and keep caseworkers and nonprofit workers employed.
